ORDER OF THE ARK AND DOVE (established 1972)

"For Distinguished Service to the College"

Ark and Dove is the best known of St. Mary's four orders. The two historical ships, **Ark** (cargo) and **Dove** (passengers), brought the first settlers to Maryland in 1634, where they established the little river port of St. Mary's City. The honorary society named for those first colonists is democratic in its designation of individuals who have given "distinguished service" to the College. It is the College's highest honor.

Process:

Any person associated with the College - trustee, faculty member, staff, student, alumnus/a - may put forward a nomination to the President of the College between October and April of the academic year. The President, in conjunction with the Executive Council, after reviewing nominations, puts forward a recommendation to the Board of Trustees in time for consideration at the May Board meeting.

The Board of Trustees then votes up or down on the nomination. If there is not a deserving candidate in any given year, there is no requirement to present the award. The award is presented at the dinner associated with the October meeting of the Board of Trustees during the next academic year.

Criteria:

The honor is given to those individuals whose enthusiastic dedication and service to the institution has been consistent and noteworthy in advancing the College's mission as a selective, public liberal arts college and vibrant community of scholars and learning. Recipients will have made significant contributions in any one or more of the following:

- advancing the academic excellence of the curriculum
- facilitating opportunities for students to engage in meaningful experiential learning
- promoting faculty excellence and development
- cultivating an environment of honesty, civility, integrity, equity and inclusion that reflects the values inherent in the St. Mary's Way to create an environment where all students, faculty and staff thrive
- enhancing co-curricular programs that enrich the student experience and that foster an environment of collaboration, personal achievement and good sportsmanship that promotes school spirit and pride within the college community
- mentoring students

- leveraging the academic opportunities associated with the rich history of the college and its location
- otherwise providing extraordinary love for and support of the College

The Ark and Dove Award is an award of commitment. Financial support is not a defining factor.

The individual must:

- be living individual at the time of the nomination
- conduct themselves in a manner that exemplifies the St. Mary's Way, so that students, faculty, staff, and alumni, are inspired by the recognition and proud of the way in which it reflects on the College

The individual must not be

- be a current member of the Board of Trustees, faculty, staff, student body, Foundation Board, or Alumni Association Board, or relatives, employees or employers thereof
- an individual holding a current state or federally elected office or be running for one
- a previous recipient of the award
