ELIGIBILITY:

I, the undersigned, am applying for a Nonresident Tuition Exemption for eligible Maryland high school graduates at St. Mary's College of Maryland and I declare the following:

- 1. I attended a public or nonpublic high school in Maryland for at least three academic years not earlier than the 2005-2006 school year; (official high school transcripts required)
- 2. I graduated from a public or nonpublic high school in Maryland or received the equivalent of a high school diploma from the state not earlier than the 2007-2008 school year;
- 3. I am enrolling in the community college that serves the same jurisdiction as the high school from which I graduated; in the case of a GED student, I am enrolling in the community college that serves the same jurisdiction of the high school I last attended;
- 4. I, or my parent or legal guardian, have filed Maryland income tax returns:
 - a. annually for three years that coincide with the individual's attendance at high school in Maryland (home-schooled students are subject to the same attendance requirement);
 - b. annually during the period, if any, between graduation from high school and enrolling in a community college; and
 - c. I will continue to submit proof of tax filings each year I am enrolled at the community college. (Certified Maryland tax returns from the Comptroller of Maryland Office are required.) For more information visit:

- 5. I am enrolling at this institution not later four years after graduating from high school or receiving a GED:
